<ul style="list-style-type: none"> • All vendors must sell hand made, original art or products • This is an outdoor festival held in the streets of downtown Woodstock • Booth space is 10 by 10. The space may be on the street or on the sidewalk area, you may purchase two spaces if needed, \$50.00 per space. Applications must be accompanied by payment to secure space. • Donations to Greenprints Alliance are encouraged as a percentage of sales after the event to be determined by the artist. • Vendors must provide their own tables, chairs, tents, shelves, racks, extension cords etc. • Please note that it may not be possible to drive a vehicle directly to your booth space. • Exhibit hours are 11:30 a.m. until the close of the event. Setup will begin at 9:00am, all vendors must stay through 6:30pm, the last band is scheduled to start at 7:00 pm and you are welcome to stay until the close of the event. • Tear down of your booth may begin at 6:30 PM and must be completed that evening • Fee is non-refundable due to cancellation on your part or inclement weather. This is a "rain or shine event"---no rain date. • Exhibit spaces will be arranged by the Streetfest organizers according to the order of application received, paid application fee, and what works best for the flow of the festival. • Confirmation will be sent prior to the festival, along with all check-in information. • Estimated attendance of last year's festival around 5,000
